BAC RESOLUTION DECLARING DAVAO LIVESTRONG BUILDERS CORPORATION AS LCRB FOR THE REPAIR AND RENOVATION OF CHSS DEPARTMENT OF ARCHITECTURE CONSTRUCTION LABORATORY

WHEREAS the University of the Philippines Mindanao through its Bids and Awards Committee (BAC) posted the Invitation to Bid for the Repair and Renovation of CHSS Department of Architecture Construction Laboratory with an Approved Budget for the Contract (ABC) in the amount of ₱2,430,940.73 on the PhilGEPS website and the website of UP Mindanao and in a conspicuous place in the University campus for seven (7) consecutive days;

WHEREAS, as a result of such postings, three (3) bidders purchased bid documents and submitted their bids on the deadline, 1 June 2021, namely Davao Livestrong Builders Corporation, ACJ Construction Resources and Standel Corporation;


WHEREAS, after preliminary examination of the documents using “pass/fail” non-discretionary criteria, among the above-stated three (3) bidders, the BAC declared only one (1) bidder, Davao Livestrong Builders Corporation, eligible with a bid amount of ₱2,405,629.61;


WHEREAS, the Technical Working Group and the BAC conducted a thorough evaluation and re-calculation of the submissions of the said eligible bidder (Davao Livestrong Builders Corporation) it was found to be compliant and the amount in figure is consistent with the amount in words;


WHEREAS, the Technical Working Group conducted its Post-Qualification evaluation on the technical and financial documents received. As a result, Davao Livestrong Builders Corporation is found Compliant and is hereby declared as Lowest Calculated and Responsive Bid (LCRB);


NOW THEREFORE, we, the members of the Bids and Awards Committee present during the meeting, hereby resolve to recommend the award of contract to the Head of Procuring Entity;


