BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID FOR THE NEGOTIATED PROCUREMENT (TWO-FAILED BIDDINGS) FOR THE REPAIR OF FIRE ALARM SYSTEM AT EBLH PBM2021-16INF

WHEREAS the University of the Philippines Mindanao through its Bids and Awards Committee (BAC) posted the Invitation to Bid for the Negotiated Procurement (Two-Failed Biddings) for the Repair of Fire Alarm System at EBLH PBM2021-16INF, with an Approved Budget for the Contract (ABC) in the amount of ₱1,099,997.85 on the PhilGEPS website and the website of UP Mindanao and in a conspicuous place in the University campus for seven (7) consecutive days;;

WHEREAS, as a result of such postings only Legacy Construction Corporation submitted its bid on the deadline, 2 July 2021;

WHEREAS, after preliminary examination of the documents using "pass/fail" non-discretionary criteria, as a resolution the BAC declared the lone bidder, eligible with the bid amount of ₱1,049,651.74;

WHEREAS, Section 32.2 of the 2016 Revised IRR authorizes the BAC to evaluate the financial component of the bids to determine the Lowest Calculated Bid;

WHEREAS, after the Technical Working Group and the BAC conducted a thorough evaluation and re-calculation of the bid submitted, the result is still the same amounting to ₱1,049,651.74;

WHEREAS, the Bids and Awards Committee, as a resolution, declared Legacy Construction Corporation's bid as the Lowest Calculated Bid (LCB) and then submitted their Post-Qualification Requirements Notice;

WHEREAS, Technical Working Group conducted its Post-Qualification evaluation on the technical and financial documents submitted by Legacy Construction Corporation, and is found to be compliant;

WHEREAS, based on the report and the recommendation of the TWG and the BAC, Legacy Construction Corporation is found to be compliant and hereby declared as the Lowest Calculated and Responsive Bid (LCRB) and to recommend to award the project, to the Chancellor;
