BAC Resolution No. 09 s. of 2022

DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT FOR LOT 5 – GRADIENT THERMAL CYCLER OF THE EQUIPMENT OUTLAY FOR THE ABRAHAM: PROJECT I FISH DIVE (PBM 2022-04)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid of the Equipment Outlay for the ABRAHAM: Project I Fish Dive (PBM2022-04) consisting of five (5) lots with a total approved budget for the contract (ABC) in the amount of P4,865,000.00;

WHEREAS, as a result of such postings three (3) bidders submitted their bids upon the deadline for submission on May 4, 2022;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared all the three bidders to be eligible for bidding, namely: 1) Golden Bat (Far East) Inc., 2) Medical Test Systems and 3) Rain Phil Inc.;

WHEREAS, upon opening and checking of the financial envelopes the following were the bids as read, namely:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by Rain Phil Inc., the lowest calculated bidder and also those of Golden Bat (Far East) Inc., the second lowest bidder for Lot 4 – Laboratory Refrigerator etc., their bids were found to be non-compliant to the technical specifications, thus both bidders were post disqualified;

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by Medical Test Systems, the lone bidder for Lot 5-Gradient Thermal Cyclers, its bid was found to be compliant and responsive to the technical specifications;


NOW THEREFORE, we the members of the BAC for Goods hereby **RESOLVE** the following:






