BAC-INFRA-CS Resolution No. 10 s. of 2021

BAC RESOLUTION DECLARING THE FAILURE OF BIDDING AND REBIDDING OF REPAIR OF FIRE ALARM SYSTEM AT THE ELIAS B. LOPEZ HALL

WHEREAS the University of the Philippines Mindanao through its Bids and Awards Committee (BAC) posted the Invitation to Bid for the Repair of Fire Alarm System at EBLH, UP Mindanao with an approved budget for the contract in the amount of ₱1,099,997.85 on the PhilGEPS website and the website of UP Mindanao and in a conspicuous place in the University campus for seven (7) consecutive days;

WHEREAS, as a result of such postings two (2) bidders purchased bid documents and submitted their bids on the deadline, April 27, 2021;

WHEREAS, the two bidders, namely Legacy Construction and MAG Corporation submitted financial bids as follows:

₱1,049,651.74
₱1,092,576.87

WHEREAS, after preliminary examination of the documents using "pass/fail" non-discretionary criteria, the BAC declared both bidders as compliant;

WHEREAS, Section 32.2 of the 2016 Revised IRR authorizes the BAC to evaluate the financial component of the bids to determine the Lowest Calculated Bid;

WHEREAS, after the Technical Working Group and the BAC conducted a thorough evaluation and re-calculation of the bid submitted by Legacy Construction Corporation and Mag Corporation, it was found that:

- Legacy Construction Corporation submitted the bill of quantities for the Repair of Fire Alarm System at Admin/CHSS and Main Library, UP Mindanao amounting to ₱2,281,616.01, which is not consistent as the bid as read; and
- 2. Mag Corporation's recalculated bid amount is ₱1,141,757.19, which is also not consistent with the bid as read;

NOW THEREFORE, we, the members of the Bids and Awards Committee present during the meeting, hereby resolve the following:

1. To declare Legacy Construction Corporation and Mag Corporation, non-compliant;

To declare a failure of bidding for the Repair of Fire Alarm System at EBLH, UP Mindanao since there is no eligible bidder.
