## DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF VARIOUS EQUIPMENT AND SUPPLIES FOR CSM-DMPCS

WHEREAS the University of the Philippines Mindanao through its Bids and Awards Committee (BAC) posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid for the Procurement of Various Equipment and Supplies for the CSM-DMPCS with an approved budget for the contract (ABC) in the amount of P1,361,000.00 which was later on divided into two lots per Bid Bulletin No. 01-2020, with the following details:

Lot Number	Description	Approved Budget (PhP)
Lot 1	Electronic Whiteboard	600,000.00
Lot 2	Full HD Camcorder, etc.	761,000.00

WHEREAS, despite observance of such posting requirements only one (1) bidder, AVLS Lights Visual & Lights Systems Corporation submitted its bid for Lot 1 while no bid was received for Lot 2 upon the deadline for submission on December 28, 2020;

WHEREAS, upon opening and preliminary examination of the bid documents, the lone bidder was declared eligible for bidding;


WHEREAS, upon opening of the financial envelope submitted for Lot 1, the following was the bid as read, namely:

WHEREAS, after the thorough evaluation of the bid documents submitted by the lone bidder, its bid was found to be compliant to most of the important technical specifications with sufficient justification from the end-user;

NOW THEREFORE, we the members of the Bids and Awards Committee hereby resolve to declare AVLS Lights Visual & Lights Systems Corporation to be the Single Calculated and Responsive Bid (SCRB) and recommend it for award of contract for Lot 1 in the amount of P438,600.00.


