

## BAC Resolution No. 13 s. of 2022

## RECOMMENDING THE AWARD OF CONTRACT FOR LOT 1 - ASIMOV HAWKS PROJECT EQUIPMENT NEGOTIATED PROCUREMENT AFTER TWO FAILED BIDDINGS- PBM 2022-06

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Notice for Negotiated Procurement of the Asimov HAWKS Project Equipment consisting of two (2) lots with a total approved budget for the contract (ABC) in the amount of P172,800.00;

WHEREAS, as a result of such postings one bidder submitted their bid upon the deadline for submission on May 12, 2022;

WHEREAS, after the preliminary checking of the requirements, the BAC declared the lone bidder, Wise 82 Tech Builders, Inc., to be eligible for this negotiated procurement,

WHEREAS, upon opening and checking of the financial envelope of Wise 82 Tech Builders the BAC found the bid for Lot 1 – consisting of Biometric Lock Assembly, QR-Based Inventory System, and CCTV Kit in the amount of P149,994.88 to be within the approved budget for the contract (P150,000.00);

WHEREAS, after the thorough evaluation and post qualification the Technical Working Group reported that the bid was not compliant for the following reasons, namely: 1) Item I Biometric Lock Assembly was not multipurpose system, and 2) there is no card access and there were no cards indicated in the offer,

WHEREAS, upon receipt of the BAC notice on May 23, 2022 that it was post-disqualified, Wise 82 Tech Builders submitted a request for reconsideration on May 25, 2022 which is within the allotted timeframe for submission of such requests;

WHEREAS, after the end-user conducted a review of the specifications and verified the bid offer of the lone bidder, it was found out that the unit being offered is equipped with fingerprint and card access control system through the link provided; moreover, the bidder clarified that the access cards shall be provided;

WHEREAS, a demonstration of the unit was conducted in the presence of representatives from the end user unit and after the said demonstration they informed the BAC that the product's multi-purpose system complies with the technical requirements for this procurement project;

NOW THEREFORE, we the members of the Bids and Awards Committee for Goods hereby RESOLVE the following:

- To declare the bid of Wise 82 Tech Builders, the lone bidder for Lot 1 Biometric Lock Assembly, QR-Based Inventory System, and CCTV Kit of the Asimov Hawks Project Equipment negotiated procurement after two failed bidding, as compliant and responsive;
- To recommend that the contract for Lot 1 be awarded to Wise 82 Tech Builders with a contract price in the amount of P149,994.88;
- 3) To endorse the foregoing for approval by the Chancellor of UP Mindanao.

RESOLVED through a referendum on June 10, 2022, Davao City, Philippines.
