DECLARING SINGLE RATED AND RESPONSIVE BID (SRRB) AND RECOMMENDING AWARD OF CONTRACT

CONSULTING SERVICES - DETAILED ARCHITECTURAL AND ENGINEERING SERVICES OF THE COLLEGE OF HUMAN KINETICS (CHK) BUILDING REBIDDING

WHEREAS, the University of the Philippines Mindanao through its Bids and Awards Committee (BAC) posted the Request for Expression of Interest for the rebidding of the Detailed Architectural and Engineering Design Services (DAEDS) of the UP Mindanao College of Human Kinetics (CHK) Building with an Approved Budget for the Contract (ABC) in the amount of P7,000,000.00 on the PhilGEPS website, on the UP Mindanao website and in a conspicuous place within the UP Mindanao premises for seven (7) calendar days;

WHEREAS, in response to the said advertisement three architectural firms submitted their eligibility documents on December 10, 2020 but only Palafox Associates passed the eligibility check and was evaluated for shortlisting;

WHEREAS, the results of the shortlisting and evaluation of the Eligibility documents showed that Palafox Associates garnered a total score of 95.17% which is above the required minimum score of 70% for shortlisting;

WHEREAS, before the deadline on December 28, 2020 the lone eligible bidder submitted its Technical and Financial Proposals and upon opening and preliminary examination of the Technical Proposal and the oral presentation made by the firm's representative of the conceptual design, the BAC, using "pass/fail" non-discretionary criterion, found the bidder eligible for bidding;

WHEREAS, after the Technical Working Group evaluated the Technical Proposal using Quality Based Evaluation Procedure (QBE) which was expressly stated in the bid documents along with the approved evaluation criteria Palafox Associates being the Single Rated Bid (SRB) garnered a total rating of 98.84%, which is above the minimum required score of 70%;

WHEREAS, upon opening of the Financial Proposal its bid amounting to P6,789,090.00, inclusive of all taxes and fees, did not exceed the ABC;

WHEREAS, after the negotiation conducted on December 29, 2020 to clarify some issues in the bidder's proposal vis-à-vis the requirements in the Terms of Reference, the BAC resolved to declare Palafox Associates as the Single Rated and Responsive Bid;

NOW THEREFORE, we, the members of the BAC hereby RESOLVE to recommend the approval of the award of the contract for the Detailed Architectural and Engineering Services of the College of Human Kinetics (CHK) Building to Palafox Associates in the amount of P6,789,090.00;
