BAC Resolution No. 04 s. of 2023

DECLARING LOWEST/SINGLE CALCULATED AND RESPONSIVE BID (LCRB/SCRB) AND RECOMMENDING AWARD OF CONTRACT FOR LOTS 1 & 2 OF THE NEGOTIATED PROCUREMENT (TFB) FOR THE SUPPLY OF EQUIPMENT (UPS AND VAULT) FOR THE ALAM-LSI PROJECT (PBM 2022-32)

WHEREAS, after two failed biddings the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Notice for Negotiated Procurement (Due to Two Failed Biddings) of the Supply of Equipment (UPS and Secure Vault System) for the ALAM-LSI Project (PBM 2022-32) with an approved budget for the contract (ABC) in the amount of P500,000.00 for Lot 1 and P100,000.00 for Lot 2;

WHEREAS, as a result of such postings three (3) bidders submitted their bids upon the deadline for submission on December 22, 2022;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared all the three bidders to be eligible for bidding, namely: 1) Comfac Corporation; 2) iEquity Technologies Corporation, and 3) Wise 82 Tech Builders Inc.;

WHEREAS, upon opening and checking of the financial envelopes the following were the bids as read as shown in the attached Abstract of Bids as Read (Annex A), namely:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by Comfac Corporation, the Lowest Calculated Bid (LCB) for Lot 1-High End UPS, the Technical Working Group's Report (Annex B) as well as that of the end-user (Annex C) declared their bid to be compliant to the technical specifications;

WHEREAS, upon evaluation and post qualification of the lone bid submitted by Wise 82 Tech Builders for Lot 2-Secure Vault System, their bid was found to be compliant to the technical requirements;

NOW THEREFORE, we the members of the Bids and Awards Committee for Goods hereby RESOLVE as it is hereby RESOLVED the following:

- To declare COMFAC Corporation as the Lowest Calculated and Responsive Bid (LCRB) for Lot 1 High End UPS and to recommend the award of the contract in the amount of P480,000.00 to the said bidder;
- To declare Wise 82 Tech Builders as the Single Calculated and Responsive Bid (SCRB) for Lot 2 Secure Vault System and to recommend the award of the contract in the amount of P97,842.89 to the said bidder.
- To recommend the foregoing findings for approval by the Chancellor.
