Completion of Track Oval: Delivery and Installation of Synthetic Track System and Other Facilities


This Bid Bulletin is issued for the following reasons:

<p>i. Clarifications received from various bidders.</p> <p>a. "Our company is a platinum member of PhilGEPS and we are entering into a Joint Venture Agreement with a foreign companies from Korea certified as not registered corporations in the Philippines by SEC for the projects a) Completion of Track Oval: Delivery and Installation of Synthetic Track System and other facilities b) Completion of Football Field: Delivery and Installation of Synthetic Turf System.</p> <p>Do these foreign companies still need to be registered with PhilGEPS? Or we will just submit equivalent documents, i.e. (Corporate Registration, Business Permit, Tax Clearance, Audited Financial Statement) Translated, notarized and certified by the Korean Embassy."</p> <p>b. "We would like to inquire on deriving the completion rate of projects. With regards to actual installation, E-Sports gauge completion based on contractor's estimated percentage of accomplished work. However, we are unsure as to how to estimate percentage completion of projects whose materials are still on transit. Please note that the production of Limonta turf takes about a month and the materials has been fully paid by E-Sports. It is ready to be shipped next week and will arrive the site by first of second week of August. Your advise on the matter will be greatly appreciated since we would like to conform to the requirements of UP Mindanao BAC."</p> <p>c. "In case our foreign partner has no available document (i.e. PhilGEPS) should we submit a statement of Not Available instead?"</p> <p>d. "In case we don't have similar completed project, can we use our foreign partner's list of completed projects abroad?"</p> <p>e. "For technical specifications documents: Are we going to fill up the specifications column? The document we have has no entry on the specifications column."</p>	<p>Please refer to Section 23.1 b, 23.2 of the 2016 Revised IRR of RA9184</p> <p>The completion rate of each project should be computed based on actual work done and installed on site. Therefore, materials that have been purchased, are on transit, or already delivered on site but are not yet installed cannot be considered as work accomplished or completed.</p> <p>Please refer to Section 23.1 b, 23.2 of the 2016 Revised IRR of RA9184</p> <p>No. The local partner entering into the Joint Venture Agreement is required to have completed at least one (1) similar local project.</p> <p>Please see attached Technical Specifications Form.</p>

<p>f. "We need a plan of Football stadium showing the detail of the rise and run of the bleachers for the 2000 pcs seats requirements. We have 3-set up of installation that depends on the dimension of the rise and run of the bleachers."</p>	<p>Please see attached plan showing the rise and run of the bleachers. Sheet A-01 shows the bleachers section of the Football Stadium Phases 1 and 2 where the 1800 units simple-mounted fiberglass football stadium seats with medium-height (30cm) backrest are to be installed.</p>
<p>g. "With regards to the Technical Specifications Item E. We just want to clarify if ground embed equipment is included?"</p>	<p>If this refers to the project record documents to be submitted prior to final acceptance of the project, yes, the ground embed equipment shall be included. The project records should be as comprehensive and extensive as possible.</p>
<p>h. "We would like to clarify regarding warranty submitted during BID Opening, is it a sample or draft warranty package. But it is indicated in the Warranty & Guarantee no. 7 page 7 of 15 of Technical Docs during the Bid a Sample Policy must be provided. A letter from an agent of a sample Certificate of Insurance will not be acceptable. It is contradicted. Which of which we need to submit. A sample policy only or we need to enroll already it to the insurance. But as per Insurance they will provide insurance policy if the project is already awarded. In our thinking we only attached Sample Policy of the Insurance. Hoping to receive clarification on this matter."</p>	<p>Minimum pre- paid five (5) year insured warranty Insured Warranty Coverage must be provided in the form of 1 single policy.</p>
<p>i. "Two companies with JVA represent two (2) different products. Will the BAC accept references using a different brand than the one being offered in the bid?"</p>	<p>All products offered in each bid, including all accessories, should be the products that the bidder will supply and install. References to other brands that the bidder will not supply and install for the project should be explicitly designated as "For reference only. Not included in bid." It can be purchased as part of similar projects completed.</p>
<p>j. "Will the bid price be quoted at CIF? This means that UP Mindanao will be the consignee. This also indicates that the documents to be used to release the shipment will be those of UP Mindanao. However, if UP Mindanao will go into an MOA with the PSC, then all documents of the PSC will be used for this particular project for tax-exemption purposes."</p>	<p>All costs should be borne by the bidder including customs duties, brokerage, and other related expenses. Delivered and installed in UP Mindanao.</p>
<p>k. "Is it okay if we can have our product presentation?"</p>	<p>Since the bidding for the Synthetic Track and Turf are already ongoing, we will no longer entertain product presentations. Bidders shall be given a similar opportunity during the oral presentations, which is part of the bidding process.</p>
<p>l. "One of the companies in the JVA does not have a PhilGEPS Platinum certificate. Will this be a reason for disqualification? Will it be acceptable if the Platinum certificate be given at a later date? It will take 3 weeks to upgrade the said classification and might not make in time of the bid."</p>	<p>Please refer to Section 23.1 b, 23.2 of the 2016 Revised IRR of RA9184</p>
<p>m. "This is to confirm that the FIFA Lab test for FIFA Quality Pro System will only be given post bid and before construction of football field."</p>	<p>Yes, FIFA Lab test for FIFA Quality Pro System will only be given post bid and before construction of football field followed by field testing by FIFA prior to turn over of the facility to UP Mindanao.</p>
