Description

REQUEST FOR EXPRESSION OF INTEREST

The University of the Philippines Mindanao, through the General Appropriations Act of 2015 intends to apply the following Approved Budget for the Contract (ABC) amounting to One Million Five Hundred Ninety Thousand Nine Hundred Nine Pesos and Nine Centavos (P1,590,909.09) to payments under the project Construction Management Services for the Construction of the Center of Advancement of Research in Mindanao (CARIM) Building Phase 2.

Bids received in excess of the ABC shall be automatically ejected at the opening of financial proposals. The University of the Philippines Mindanao now calls for the submission of eligibility documents for the above-mentioned project. The University requires the services of a Construction Management Consultant whose on-site presence will ensure that daily construction activities satisfy standards of quality and timeliness for the construction of the CARIM Building – Phase 2. Interested consultants must submit their eligibility documents on or before December 1, 2016 at 9:00 AM at the 2/F Administration Building, UP Mindanao, Mintal, Davao City. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.

The BAC shall draw up the short list of consultants from those who have submitted eligibility documents and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise

known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list consist of all eligible prospective bidders who will be entitled to submit bids.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

The Procuring Entity shall evaluate bids using the Quality-Cost Based Evaluation (QCBE): Eligibility/Technical = 70 points; Financial = 30 points. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.

The contract shall be completed within Four Hundred Five (405) calendar days.

The University of the Philippines Mindanao reserves the right to reject any and all bids, annul the bidding process, or not to award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
