Invitation to Bid for the Construction of One (1) Storey Upland Training Center at UP Mindanao Land Reservation in Marilog, Davao City

- 1. The University of the Philippines Mindanao, through the GOP 2016 Reprogrammed Funds of the University, intends to apply the sum of P1,999,771.99 being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of One (1) Storey Upland Training Center at UP Mindanao Land Reservation in Marilog, Davao City per Bidding Contract No. 2018-003. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The University of the Philippines Mindanao now invites bids for Construction of One (1) Storey Upland Training Center at UP Mindanao Land Reservation in Marilog, Davao City. Completion of the Works is required 120 calendar days from receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from University of the Philippines Mindanao and inspect the Bidding Documents at the address given below during office hours (8:00 a.m. to 5:00 p.m).
 - 5. A complete set of Bidding Documents may be acquired by interested bidders starting May 7, 2018 from the address below upon payment of the non-refundable fee for the Bidding Documents in the amount of P5,000.00, pursuant to the latest Guidelines issued by the GPPB.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the University, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The University of the Philippines Mindanao will hold a Pre-Bid Conference on **May 15, 2018, 9:00 a.m.** at Gaisano Conference Room 2nd Floor Administration Building, UP Mindanao, Mintal, Davao City which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC thru its Secretariat at the address below on or before **May 28, 2018, 9:00 a.m.**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause .1.27..

Bid opening shall be <u>May 28, 2018, 9:00 a.m.</u> at *Lorenzo Hall, Ground Floor Administration Building, UP Mindanao, Mintal, Davao City.* Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The University of the Philippines Mindanao reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
