BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee, posted the Invitation to Bid of the Repair of EBL Hall Comfort Rooms with an approved budget of Nine Hundred Ninety Nine Thousand Nine Hundred Forty Four and 42/100 Pesos Only (P999,944.42) in the PhilGEPS website, in the UP Mindanao website, and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days;

WHEREAS, as a result of these postings four bidders purchased bid documents and submitted their bids upon the deadline for submission on August 28, 2018;

WHEREAS, upon opening and preliminary examination of the technical requirements using non-discretionary pass or fail criteria, only two bidders were declared eligible for bidding, namely J&S Escuadra Construction and Supply and Ritztok Construction & Supply;

WHEREAS, after opening and preliminary examination of bids, the following were the bids as read:

Amount of Bid	P985,390.64	P988,777.84
Bid Security / Remarks	Bid Securing Declaration / Sufficient	Surety Bond / Sufficient

WHEREAS, upon evaluation and re-calculation of the bid submitted by Ritztok Construction & Supply, it was found that its bid was computed using a tax rate of only 10.71% and the re-calculated bid amount was actually P1,091,907.12, which was already above the ABC;

WHEREAS, there was no motion for reconsideration received from Ritztok Construction & Supply even after the Bids and Awards sent a letter on 19 September 2018 informing them of the re-calculated bid amount;

WHEREAS, upon evaluation and post qualification of the bid submitted by the second bidder, J&S Escuadra Construction Supply, its bid was found compliant and responsive;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare J&S Escuadra Construction Supply as the Lowest Calculated and Responsive Bid and recommend it for award of the contract for the Repair of EBL Hall Comfort Rooms in the amount of P988,777.84;


