DECLARING AWARD OF CONTRACT FOR LOT 2 AND LOT 3 AND RECOMMENDING NEGOTIATED PROCUREMENT (AFTER-TWO-FAILED-BIDDINGS) FOR LOT 4 FOR THE RE-BIDDING OF SUPPLY OF EQUIPMENT (UPS, CCTV & BIOMETRICS, CAMERA, VAULT) FOR THE ALAM-LSI PROJECT PBM 2022-11

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid for the Rebidding of Supply of Equipment (UPS, CCTV & Biometrics, Camera, Vault) for the ALAM-LSI Project (PBM 2022-11) with a total approved budget for the contract (ABC) in the amount of P1,100,000,000.

WHEREAS, as a result of such postings, four (4) bidders: Wise 82 Tech Builders, Inc., Automation Specialists and Power Exponents Inc, Iequity Tech. Corp, and R3hub 1T Solutions submitted their bid before the deadline for submission on July 13, 2022 and were found to be eligible;

WHEREAS, upon opening and preliminary examination of their financial component, their bids were as follows:

WHEREAS, after evaluation the following bidders were declared as the Lowest Calculated Bid (LCB):

WHEREAS, upon the result of the Post-Qualification Evaluation of the Technical Working Group (TWG) submitted on July 29, 2022 (see Annex A), the report reflected that for Lot 1- Automation Specialists and Power Exponents Inc's bid was compliant with the technical requirements contrary to the end-user's evaluated report dated July 15, 2022 and August 3, 2022 (see Annex B and C) that it was non-compliant due to the following reasons:

- Bypass not specified on manufacturer's website;
- Back up time stated on manufacturer's website is different from the bid documents; and
- Smart UPS feature not explicitly stated on the manufacturer's website.

WHEREAS, due to conflicting results between the TWG and End-user, the BAC sought the technical expertise from UP-ITDC. Upon the latter's evaluation dated August 17, 2022 (see Annex D), ITDC found the bid of Automation Specialists and Power Exponents Inc. is compliant.

WHEREAS, upon presentation of the ITDC's evaluation result, the end-user requested through its letter on August 22, 2022 (see Annex E), for a verification of the performance of the UPS offered by the lowest bidder- Kemapower RXG10K – by product demonstration and testing in UP Mindanao. On August 25, Ms. Mandasoc (representative of Automation Specialists and Power Exponents Inc) requested to demonstrate/ test the unit through Zoom/Microsoft Teams (see Annex F). Furthermore, after consultation with the end-user, the BAC through its letter dated August 31, 2022 (see Annex G), agreed to conduct the demonstration/testing in UP Mindanao on September 20, 2022 at 9:00 A.M.

WHEREAS, upon the result of the Post-Qualification Evaluation of the Technical Working Group (TWG) submitted on July 29, 2022 (see Annex A), the Lowest Calculated Bidder for Lot 2 and 3, Wise 82 Tech Builders, Inc and Iequity Tech. Corp, were found to be compliant.

WHEREAS, a notice of post-qualification was issued to Wise 82 Tech Builders, Inc. for Lot 2 and lequity Tech. Corp for Lot 3 and the BAC decided to proceed the recommendation to award while waiting for the product demonstration of Lot 1;

NOW THEREFORE, we the members of the Bids and Awards Committee hereby resolve the following:

- To recommend the award of Lot 2 to Wise 82 Tech Builders, Inc.;
- To recommend the award of Lot 3 to Iequity Tech. Corp; and
- To recommend the negotiated procurement (After Two-Failed-Biddings) for Lot 4.
