



BAC Resolution No. 16 s. of 2022

**DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB)
AND RECOMMENDING AWARD OF CONTRACT**

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid of the Supply of Laboratory Equipment for the Implementation of TTBD0 Augmentation Project (PBM 2022-13) consisting of two (2) lots with a total approved budget for the contract (ABC) in the amount of P2,200,000.00;

WHEREAS, as a result of such postings two (2) bidders submitted their bids upon the deadline for submission on August 1, 2022; In view of a lack of quorum, the opening of bids was postponed to August 2, 2022 with the Notice of Postponement duly posted on the PhilGEPS and UP Mindanao websites;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared only one bidder of Lot 1, Instrumix Supplier, to be eligible for bidding while the lone bidder of Lot 2, Krypton International Resources, was declared ineligible for the reason that one page of the Price Schedule that was submitted electronically did not bear the signature of the authorized representative contrary to the requirement stipulated in the bidding documents that each page of the Bid Form and its Price Schedule should be signed and that failure to do so would be a ground for rejection of their bid;

WHEREAS, upon preliminary checking of the financial component of the bid of Instrumix Supplier its bid for Lot 1 was read as follows:

WHEREAS, Krypton International Resources submitted its request for reconsideration pointing out that the bid forms were signed however during the conversion and adjustment from Word file to Portable Document File (PDF), the layout got separated such that one page appeared to be unsigned; After thorough deliberation the BAC decided not to grant Krypton's request for reconsideration;

WHEREAS, upon the evaluation and post qualification of the bid documents submitted by Instrumix Supplier for Lot 1, their bid was found to be compliant and responsive to all the technical specifications;

NOW THEREFORE, we the members of the BAC for Goods hereby **RESOLVE** the following:


- 1) To declare **INSTRUMIX SUPPLIER** as the single calculated and responsive bid (SCRB) and recommend the award of the contract for **Lot 1 – Fourier Transform Infrared Spectrophotometer** with contract amount of **P1,780,000.00** to the said bidder;
- 2) To recommend a re-bidding for Lot 2, and

3) To endorse the foregoing for approval by the Chancellor of UP Mindanao.


