BAC Resolution No. 10 s. of 2023

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF THE CONTRACT FOR THE REBIDDING OF THE SUPPLY, INSTALLATION AND CONFIGURATION OF PREGINET INTRA-CAMPUS NETWORK EQUIPMENT FOR THE PHILIPPINE SKY ARTIFICIAL INTELLIGENCE PROGRAM (PBM 2023-02)

WHEREAS, after one failed bidding, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Rebidding of the Supply, Installation and Configuration of PREGINET Intra-Campus Network Equipment for the Philippine Sky Artificial Intelligence Program (PBM 2023-02) with an approved budget for the contract (ABC) in the amount of P3,750,000,00;

WHEREAS, as a result of such postings four (4) bidders submitted their bid upon the deadline for submission on March 6, 2023, namely: Unicenter Corporation, Comfac Corporation, Pronet Systems Integrated Network Solution Inc. and R3Hub IT Solutions;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared the three bidders as eligible while the fourth bidder, R3Hub IT Solutions, was declared ineligible since the Mayor's permit in the PhilGEPS Platinum Certificate is not updated;

WHEREAS, upon opening and checking of the financial envelope the following bid amounts were deemed within the Approved Budget for the Contract, and declared Unicenter Corporation as the Lowest Calculated Bid (LCB) as shown in the table below:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by the LCB, the Technical Working Group as well as the representatives of the end-user unit found their bid to be non-compliant and non-responsive to the technical specifications for the Fiber Optic Cable;

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by the Comfac Corporation, the 2LCB, the Technical Working Group as well as the representatives of the end-user unit found their bid to be compliant and responsive to the technical specifications;

NOW THEREFORE, we the members of the Bids and Awards Committee for Goods hereby RESOLVE as it is hereby RESOLVED the following:

- To declare COMFAC CORPORATION as the Lowest Calculated and Responsive Bid (LCRB) for the Rebidding
 of the Supply, Installation and Configuration of PREGINET Intra-Campus Network Equipment for the Philippine
 Sky Artificial Intelligence Program (PBM 2023-02) and to recommend the award of the contract in the amount of
 P3,280,000.00 to the said bidder; and
- 2) To recommend the foregoing findings for approval by the Chancellor.
