DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF THE CONTRACT FOR THE SUPPLY OF DATA VISUALIZATION SYSTEM FOR SKAI PINAS ALAM LSI-PROJECT (PBM 2023-04)

WHEREAS, after two failed biddings, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Notice for Negotiated Procurement of the Supply of Data Visualization System for the SKAI-PINAS ALAM-LSI Project (PBM 2023-04) with an approved budget for the contract (ABC) in the amount of P700.000.00:

WHEREAS, as a result of such postings one (1) bidder submitted his bid upon the deadline for submission on March 6, 2023;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared the lone bidder, Wise 82 Tech Builders Inc., to be eligible for bidding;

WHEREAS, upon opening and checking of the financial envelope the following bid amount of Wise 82 Tech Builders Inc was deemed within the Approved Budget for the Contract:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by the lone bidder, the Technical Working Group as well as the representatives of the end-user unit found their bid to be compliant and responsive to the technical specifications;

NOW THEREFORE, we the members of the Bids and Awards Committee for Goods hereby RESOLVE as it is hereby RESOLVED the following:

- To declare WISE 82 TECH BUILDERS INC. as the Single Calculated and Responsive Bid (SCRB) for the Supply of Data Visualization System for the SKAI-PINAS ALAM-LSI Project (PBM 2023-04) and to recommend the award of the contract in the amount of P687,746.56 to the said bidder;
- 2) To recommend the foregoing findings for approval by the Chancellor.
