BAC Resolution No. 31 s. of 2023

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF THE CONTRACT FOR THE REBIDDING OF SUPPLY & INSTALLATION OF AIR CONDITIONING UNITS (PBM 2023-20)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Invitation to Bid of the Rebidding of Supply & Installation of Air Conditioning Units (PBM 2023-20) with an approved budget for the contract in the amount of P1,060,000.00;

WHEREAS, upon the deadline for submission of bids on September 5, 2023 five (5) bidders submitted bid requirements;

WHEREAS, upon the opening and preliminary checking of the Technical Envelope documents all the five (5) bidders were declared eligible for bidding, namely: 1) Invertaire Airconditioning and Refrigeration Center, 2) Airprosystems, Inc., 3) Don-Aire Conditioning Solutions, 4) JLRM IT Services, and 5) Metro Coolaire Trading;

WHEREAS, after the opening and checking of the Financial Envelope documents, it was observed that the Price Schedules of JLRM IT Services and Metro Coolaire Trading were not signed, contrary to the requirement that each page of the Bid Form and Price Schedule should be signed, therefore they were both disqualified and their representatives were informed accordingly;

WHEREAS, upon the opening and reading of bids of the three (3) eligible bidders their bids as read are presented below:

WHEREAS, after the checking and post qualification of the bid of Invertaire Airconditioning and Refrigeration Center, the Lowest Calculated Bid (LCB), the end-user noted that the length of wire for the installation of power supply was not sufficient but this was not stated in the technical specifications. However, upon clarification with Invertaire Airconditioning and Refrigeration Center, the bidder clarified that their bid is inclusive of all requirements for the installation of each unit;

WHEREAS, upon the review by the Technical Working Group of the bid of Invertaire Airconditioning and Refrigeration Center, including their clarification on the length of wire and other requirements for the installation, the TWG Reported on October 17, 2023 that Invertaire Airconditioning is compliant to the technical specifications;
