

**CONTRACT AGREEMENT****Rebidding of the Supply and Delivery of Materials for the Operationalization of Face-To-Face Classes (PBM 2023-31)**

THIS AGREEMENT made on the FEB 21 2024 day of \_\_\_\_\_ between:

The **UNIVERSITY OF THE PHILIPPINES**, the national university of the Philippines, created by virtue of Act No. 1870, as amended and re-organized and operating by virtue of Republic Act No. 9500, through its constituent unit, the **UNIVERSITY OF THE PHILIPPINES MINDANAO (UP MINDANAO)**, established by virtue of Republic Act No. 7889, with office address at Administration Building, Mintal, Tugbok District, Davao City, represented herein by its Chancellor, **LYRE ANNI E. MURAO, Ph.D.**, hereinafter referred to as the **"THE ENTITY"**;

and

The **PRINCE EDUCATIONAL SUPPLY**, with office address at 132 Bolton Street, Davao City, represented herein by its Authorized Representative, **KENNETH L. SY**, hereinafter referred to as **"THE SUPPLIER"**.

**WHEREAS**, THE ENTITY invited Bids for certain goods and ancillary services, particularly **Rebidding of the Supply and Delivery of Materials for the Operationalization of Face-To-Face Classes (PBM 2023-31)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Five Hundred Seventy-Three Thousand Eight Hundred Pesos only (P1,573,800.00)** (hereinafter referred to as **"THE CONTRACT PRICE"**).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security (in the form of Surety Bond to expire on January 2, 2025);
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.


