BAC Resolution No. 35 s. of 2023

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID FOR THE SUPPLY AND DELIVERY OF FOAM MATTRESSES FOR THE NEW STUDENT DORMITORY (PBM 2023-32)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Invitation to Bid of the Supply and Delivery of Foam Mattresses for the New Student Dormitory with project identification no. PBM 2023-32, with an approved budget for the contract (ABC) in the amount of P1,210,000.00;

WHEREAS, as a result of such posting, four (4) bidders purchased bid documents and submitted their bids upon the deadline for submission of bids on December 27, 2023;

WHEREAS, after the opening and preliminary examination of the technical envelope requirements, the BAC found that the bid from The Fort Home Decors was not password-protected. It was therefore disqualified. The other three (3) bidders were found to be eligible for bidding, namely: 1. Diness Trading, 2. DCCJ Trading, and 3. Prime Essentials Manufacturing and Trading Co.;

WHEREAS, upon opening and preliminary checking of the financial envelope requirements, the BAC read the following bids as shown in the table below:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by Prime Essentials Manufacturing & Trading Company, the Lowest Calculated Bid (LCB), their bid was found to be compliant to the technical specifications as confirmed by the representative of the end-user unit;

NOW THEREFORE, we the members of the Bids and Awards Committee for Goods hereby RESOLVE as it is hereby RESOLVED:

- To declare Prime Essentials Manufacturing & Trading Company as the Lowest Calculated & Responsive Bid and recommend the award of the contract amounting to P581,856.00 to the said bidder;
