## BAC Resolution No. 36 s. of 2023

### DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID FOR THE SUPPLY AND DELIVERY OF FURNITURE AND FURNISHINGS FOR VARIOUS NEW BUILDINGS/FACILITIES (PBM 2023-33)

**WHEREAS**, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Invitation to Bid of the Supply and Delivery of Furniture and Furnishings for Various New Buildings/Facilities with project identification no. PBM 2023-33. The procurement project consists of two (2) lots with an approved budget for the contract (ABC) amounting to P675,000.00 for Lot 1 – Furniture and Furnishings for the New Student Dormitory and P700,000.00 for Lot 2 – Furniture for the CARIM Building Phase 2;

**WHEREAS**, as a result of such postings, two (2) bidders purchased bid documents and submitted their bids upon the deadline for submission of bids on December 27, 2023;

**WHEREAS**, after the opening and preliminary examination of the technical envelope requirements, the BAC found both bidders to be eligible for bidding, namely: 1. GVG Furniture Trading, and 2. Prince Educational Supply;

**WHEREAS**, upon opening and preliminary checking of the financial envelope requirements, the BAC read the following bids as shown in the table below:

Description	GVG Furniture Trading	Prince Educational Supply
Lot 1 – Furniture and Furnishings for the New Student Dormitory	P550,000.00	No Bid
Lot 2 - Furniture for the CARIM Building Phase 2	P610,000.00	P649,500.00

**WHEREAS**, after the evaluation of bids the BAC declared GVG Furniture Trading as the Lowest Calculated Bid (LCB) for Lots 1 and 2 with their bid amounting to P550,000.00 and P610,000.00 for Lots 1 and 2, respectively;

**WHEREAS**, after the thorough evaluation and post qualification of their bid documents for Lot 1 – Furniture and Furnishings for the New Student Dormitory, GVG Furniture Trading's bid was found to be compliant to the technical specifications. However, their bid for Lot 2 – Furniture for the CARIM Building Phase 2 was found to be non-compliant for the reason that the updated technical specifications included in Bid Bulletin 1 were not complied with;

**WHEREAS**, the BAC then conducted a thorough evaluation and post qualification of the bid documents submitted by Prince Educational Supply, the next bidder for Lot 2 – Furniture for the CARIM Building Phase 2, with bid amounting to P649,500.00, their bid was found to be compliant to the technical specifications;

**NOW THEREFORE**, we the members of the Bids and Awards Committee for Goods hereby **RESOLVE** as it is hereby **RESOLVED**:

- 1) To declare **GVG Furniture Trading** as the Lowest Calculated & Responsive Bid for Lot 1 - Furniture and Furnishings for the New Student Dormitory and recommend the award of the contract for the said lot amounting to **P550,000.00** to the said bidder;

- 2) To declare **Prince Educational Supply** as the Lowest Calculated & Responsive Bid for Lot 2 - Furniture for the CARIM Building Phase 2 and recommend the award of the contract for the said lot amounting to **P649,500.00** to the said bidder;
- 3) To endorse the foregoing for approval by the Chancellor of UP Mindanao.
