## BAC RESOLUTION DECLARING HIGHEST RATED AND RESPONSIVE BID (HRRB) AND RECOMMENDING APPROVAL

WHEREAS, the University of the Philippines Mindanao posted the Request for Expression of Interest of the Detailed Architectural and Engineering Design (DAED) Consulting Services for the Construction of School of Management (SOM) Building Phase 3 (PBM 2024-02) with an approved budget for the contract in the amount of Four Million One Hundred Twenty-Six Thousand Two Hundred Forty-Four Pesos and Sixty-Nine Centavos (Php 4,126,244.69) in the PhilGEPS website, UP Mindanao website and in conspicuous places within the campus for seven (7) consecutive days;

WHEREAS, in response to said postings five (5) bidders submitted their eligibility requirements but only four (4) bidders were found eligible on May 21, 2024;

WHEREAS, in accordance with Section 24 of the 2016 revised Implementing Rules and Regulations of RA 9184, shortlisting among the eligible bidders was conducted on May 28-June 3, 2024, the results of which were duly approved by the Chancellor of UP Mindanao on June 3, 2024 per BAC Resolution No. 3 series of 2024;

WHEREAS, the following top three consultants made up the shortlist, namely:

WHEREAS, all the three bidders in the shortlist purchased bidding documents, submitted bids on June 25, 2024 and all three passed the preliminary examination of bids conducted on the same date;

WHEREAS, upon the detailed evaluation of the technical proposals using the Quality Based Evaluation (QBE) conducted on June 26-July 1, 2024, the following ranking of consultants was arrived at with BMC Architect Studio as the Highest Rated Bid:
