BAC-INFRA Resolution No. 01 s. of 2024

BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (ATLASPRIMUS CONSTRUCTION SERVICES) FOR THE PROPOSED WATERPROOFING OF ADMIN, CHSS & ATRIUM ROOF DECK (PBM 2024-03)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee (BAC) for Infrastructure posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid of the Proposed Waterproofing of Admin, CHSS & Atrium Roof Deck (PBM 2024-03) with the approved budget for the contract (ABC) amounting to ₱3,676,532.34;

WHEREAS, as a result of such postings there were three (3) bidders that submitted their bids manually upon the deadline for submission on June 4, 2024, namely: Atlasprimus Construction Services, JAH Trading & Construction and Gelbore Engineering Services ;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements, Gelbore Engineering Services was declared ineligible for bidding due to non submission of the required Bid Security while the following bidders were found eligible, namely: Atlasprimus Construction Services, and JAH Trading & Construction;

Omnibus Sworn Statement (OSS)

WHEREAS, upon opening and checking of the financial envelope, the bid amount of the following bidders were deemed within the Approved Budget for the Contract and declared eligible:

Atlasprimus Construction Services	JAH Trading & Construction
₱ 2,900,000.00	₱ 2,986,848.46

WHEREAS, the documents submitted were forwarded to the Technical Working Group (TWG) for further evaluation to ensure the completeness of the bid and apply arithmetical corrections. It was found that Atlasprimus Construction Services' bid as read and as computed are the same. The bidder was then declared by the BAC as the Lowest Calculated Bid (LCB);

WHEREAS, based on the post-qualification documents submitted by Atlasprimus Construction Services, the TWG and the BAC conducted the Post Qualification Evaluation;

WHEREAS, as a result of the Post Qualification Evaluation conducted, the TWG observed that there was no official receipt issued for the declared SLCC. The attachment submitted was only the Purchase Order and Acknowledgement Receipts;

WHEREAS, the BAC consulted with UP Mindanao Legal Counsel and was advised to require the bidder other documents to prove their SLCC. Otherwise, the BAC cannot establish whether the bidder substantially complied with the SLCC requirements;

WHEREAS, after the BAC-TWG sent a clarification letter to Atlasprimus Construction Services and its SLCC (Divine Mercy Church) to submit certificate and proof of acceptance, respectively;

WHEREAS, Atlasprimus Construction Services and its SLCC (Divine Mercy Church) submitted the notarized certificate of completion and notarized certificate of acceptance, respectively, as required by the BAC;

NOW THEREFORE, we the members of the Bids and Awards Committee for Infrastructure hereby **RESOLVE** as it is hereby **RESOLVED** the following:

- 1) To declare Atlasprimus Construction Services as the Lowest Calculated and Responsive Bid (LCRB) for the Proposed Waterproofing of Admin, CHSS & Atrium Roof Deck (PBM 2024-03); and
