BAC Resolution No. 02 s. of 2025

DECLARING WISERF TECHNOLOGIES INC. AS THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD OF THE CONTRACT FOR THE PROCUREMENT OF UP MINDANAO SMART LIBRARY (PBM 2024-16)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days, the Invitation to Bid of the Procurement of UP Mindanao Smart Library with project identification no. PBM 2024-16, with an approved budget for the contract (ABC) in the amount of P10,000,000.00;

WHEREAS, during the opening of bids on December 20, 2024, two (2) bidders submitted their bids, namely: Traceon Unotech Co. and Wiserf Technologies Inc.;

WHEREAS, upon checking the technical and financial requirements, both were found to be compliant.

Among the eligible bidders, Wiserf Technologies Inc. was declared as the lowest calculated bid (LCB), as shown in the table below;

WHEREAS, after the thorough evaluation and post-qualification of the bid submitted by Wiserf Technologies Inc., the lowest calculated bid (LCB), the TWG found that some of their offered technical specifications needed clarification. Furthermore, the TWG requested a site visit from the Library partners of Wiserf Technologies Inc. The BAC, therefore, recommended requesting clarification from the bidder on their offered items and asking them to arrange a site survey with the institutions where they have deployed their smart library equipment. This was done during the BAC meeting on January 8, 2025;

WHEREAS, on January 9, 2025, the BAC received a reply from Wiserf Technologies Inc. regarding their compliance with the technical specifications and received positive feedback, confirming that they would arrange a schedule with their Library partners;

WHEREAS, after reviewing the offered bid of Wiserf Technologies Inc. based on their reply to the letter of clarification and after conducting site visits and post-qualification checks with other clients of the bidder in the Luzon area, the TWG found their bid offer for Lot 1 and Lot 2 to be compliant and responsive to the technical specifications. The findings of the TWG were also substantiated by the end user during the BAC meeting.

- 2) To recommend the foregoing for approval by the Chancellor of UP Mindanao.
