**BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT**

WHEREAS, the University of the Philippines Mindanao, published the Invitation to Bid of the Construction of CHSS Cultural Complex with an approved budget of Forty One Million Forty Seven Thousand Pesos Only (P41,047,000.00) in the Manila Bulletin and posted the same in the PhilGEPS website, in the UP Mindanao website, and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days;

WHEREAS, as a result of such publication and postings, four (4) bids were submitted and received upon the deadline for submission of bids on 28 December 2015;

WHEREAS, out of four (4) bidders only three (3) bidders were considered eligible for bidding which included the following: 1. AIMM Builder and Construction Supply, 2. Algon Engineering Construction Corporation, and 3. FFJJ Construction;

WHEREAS, upon opening of the technical and financial requirements submitted by the three qualified bidder their bids were read as follows:
