BAC Resolution Recommending Award of the Supply of Laminar Flow, Analytical Balance and Dissecting Microscope

WHEREAS, the University of the Philippines Mindanao published the Invitation to Bid for the Supply of Laminar Flow, Analytical Balance and Dissecting Microscope with a budget of Six Hundred Thirty Five Thousand Pesos Only (P635,000.00) in the PhilGEPS website, the UP Mindanao website and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days;

WHEREAS, in response to the said advertisements, seven (7) prospective bidders purchased bid documents and submitted their bids on March 25, 2015;

WHEREAS, upon checking of the eligibility and technical documents of the seven bidders the following bidders were found ineligible due to the findings indicated below:

Name of Bidder	Findings
1. Bio Bless Enterprises	No tax clearance submitted (NPM-025-2010)
2. Drake Marketing	Audited Financial Statement is incomplete; lacks Form 1701
3. Krypton Industrial Resources	Bid Securing Declaration was not the correct format
4. Microwealth Industrial Enterprises	Audited Financial Statement is incomplete; only for one year

WHEREAS, upon checking of the eligibility and technical documents of the remaining three bidders, namely: Chemline Scientific Corporation, Elmar Marketing and Exclusive Traders, Inc. they were found to be eligible for bidding;

WHEREAS, upon opening and preliminary checking of the financial proposals of the three bidders their bids are summarized in the table below:

WHEREAS, upon thorough evaluation and post qualification of the technical and financial documents of the three bidders the following were the findings:

1. The lowest bid submitted by Exclusive Traders, Inc. for the Laminar Flow Hood was found to be non-compliant while the next bid from Elmar Marketing was found to be compliant and responsive to the specifications;
2. The bid of Elmar Marketing for the Analytical Balance is the lowest and is responsive to the specifications; and
3. The bid submitted by Exclusive Traders, Inc. for the dissecting microscope was found to be non-compliant while the next bid, that of Elmar Marketing was found to be responsive to the specifications.

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to recommend the award of all three items to Elmar Marketing with details shown below:


