CONTRACT FOR SECURITY SERVICES

This Contract for Security Services is executed by and between:

UNIVERSITY OF THE PHILIPPINES MINDANAO, a constituent unit of the UNIVERSITY OF THE PHILIPPINES, the national University of the Philippines, created by virtue of Act No. 1870, as amended and recognized and operating by virtue of Republic Act No. 9500, with office address at Administration Bldg., Mintal, Tugbok District, Davao City, represented herein by its Chancellor, LARRY N. DIGAL, Ph.D. hereinafter referred to as "UNIVERSITY".

BLACK VOLT SECURITY CORPORATION, a corporation organized and existing by virtue of Philippine laws, with office address Duha Village, San Rafael, Maa, Davao City, duly represented Lerein by its CEO, PETER PAUL JED C. FALCON, hereinafter referred to as the "AGENCY".

RECITALS:
