- 2. The University of the Philippines Mindanao now invites bids for the Supply of Physical Education Equipment (2nd Bidding). Delivery of the Goods is required thirty (30) calendar days from receipt of Notice to Proceed. Bidders should have completed, within five years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

- 6. A complete set of Bidding Documents may be acquired by interested Bidders starting November 29, 2016 from the address below and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB. Only payments in cash or Manager's/Cashier's Check payable to UP Mindanao may be accepted.
- 7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
- 8. The University of the Philippines Mindanao will hold a pre-bid conference on December 7, 2016 at 9:00 AM at the Administration Building, University of the Philippines Mindanao, Mintal, Tugbok District, Davao City, which shall be open to all interested parties.
- 9. Bids must be delivered to the address below on or before December 19, 2016 at 9:00 AM. All Bids must be accompanied by a bid security which may be Bid Securing Declaration or any other form of bid security and in the amount stated in ITB.18. Late bids shall not be accepted.
- 10. Bid opening shall be on December 19, 2016, 9:00 AM at the Administration Building, UP Mindanao, Mintal, Tugbok District, Davao City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.
