In view of the increase of F1, F2 and F3 cases among our personnel, the Administration Building is hereby temporarily closed from 14-18 June 2021 to conduct deep cleaning, disinfection and misting. During this period all personnel will be on work from home arrangement.

Please be informed that due to this temporary arrangement, all DV transactions and check issuances will be affected. However, requests and other documentary requirements may be submitted via email for appropriate action.
