DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT FOR LOT 1 – WATER PURIFICATION SYSTEM OF THE EQUIPMENT OUTLAY FOR THE FACILITY UPGRADE OF THE CORAL REEF RESILIENCY AND ECOLOGY STUDIES (CRREST)

WHEREAS, the University of the Philippines Mindanao, through its Bids and Awards Committee for Goods (BAC), posted on the PhilGEPS website, on the UP Mindanao website, and in a conspicuous place within the campus for at least seven (7) calendar days the Invitation to Bid of the Equipment Outlay for the Facility Upgrade of the Coral Reef Resiliency and Ecology Studies Laboratory (PBM 2022-05) consisting of six (6) lots with a total approved budget for the contract (ABC) in the amount of P1,441,000.00;

WHEREAS, as a result of such postings two (2) bidders submitted their bids upon the deadline for submission on May 3, 2022;

WHEREAS, after the preliminary checking of the eligibility and technical envelope requirements the BAC declared the two bidders to be eligible for bidding, namely: 1) Krypton Industrial Resources, and 2) Air Prosystems Inc.;

WHEREAS, upon opening and checking of the financial envelopes the following were the bids as read, namely:

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by Krypton Industrial Resources, the lone bidder for Lot 1 – Water Purification System, its bid was found to be compliant and responsive to the technical specifications;

WHEREAS, after the thorough evaluation and post qualification of the bid documents submitted by Air Prosystems Inc., the single bidder for Lot 5-Split-Type Aircon, its bid was found to be non-compliant to the technical specifications, particularly the EER requirements;

NOW THEREFORE, we the members of the BAC for Goods hereby RESOLVE the following:

1) To declare **Krypton Industrial Resources** as the single calculated and responsive bid (SCRB) and recommend it for award of the contract for Lot 1 – Water Purification System with contract amount of P878,680.00;
