WHEREAS, the University of the Philippines Mindanao, published the Invitation to Bid of the Supply of Air Conditioning Units and Other Equipment in the Manila Bulletin and posted the same in the PhilGEPS, UP Mindanao website and in a conspicuous place in the premises of the University of the Philippines Mindanao continuously for 7 days;

WHEREAS, in response to the said advertisements, three (3) bidders submitted their bid documents but only two were accepted by the Bids and Awards Committee since the third one was submitted beyond the deadline on July 14, 2015 at 9:00 AM;

WHEREAS, upon checking the eligibility/technical duments of the two bids submitted by Better Components, Inc. and Caresystem Technology Soloni using the non-discretionary "pass/fail" criteria, only Better Components was found eligible bidding while the other bidder, Caresystem Technology Solution was disqualified for failure to the mit the Audited Financial Statement for two (2) years;

WHEREAS, upon receipt of a Motion for Reconsideration from Caresystem Technology Solution and after the Bids and Awards Committee reviewed the eligibility documents submitted the BAC reconsidered their original decision and declared Caresystem Technology Solution as eligible to participate in public bidding;

WHEREAS, upon opening of the financial proposal of the two bidders the following were the results:

VHEREAS, upon thorough evaluation and post qualification of the bid of Better Components, Inc. for Lot 3 - Projectors, Photographic Equipment and LT, its bid was found to be non-responsive for the following reasons: 1) The specifications of the Tablet, Printer, DSLR Camera and LED Projector were not complied with; 2) The accessories were not included in the breakdown of prices;

WHEREAS, upon thorough evaluation and post qualification of the bid of Better Components, Inc. for Lot 4 - CCTV, GPS and Paging System, its bid was found to be responsive and compliant to the specifications;

NOW, THEREFORE, we, the members of the Boll and Awards Committee, hereby resolve the following:

- 1. Declare Better Components, Inc. as the sing calculated and responsive bid for Lot 4 and recommend the award of the said lot consist of CCTV, GPS and Paging System to Better Components, Inc. with its bid amounting to wo Hundred Fifty Six Thousand Pesos Only (P256,000.00);
- 2. Declare a failure of bidding and recommender second bidding for Lot 1- Air Conditioning Units; Lot 2- Appliances, Audio Visual and Corer Equipment; Lot 5 Hardware Items; Lot 6-Sports Equipment, and Lot 7 Furniture, Morpholoc Chairs and Linen.
